## THE AGREEMENT - FOR DROPOFF BEFORE SERVICE

This agreement is entered between **Scuba Dogs and the Customer** (see above) for these specified service(s). Scuba Dogs confirms that all the equipment will be **inspected, serviced and tested** by certified SCUBA technician(s) to meet manufacturer's specifications. However, the Customer understands that these are mechanical equipments that require inspection before use to assure its proper function and may fail with its normal use, wear and tear. Thus, the Customer agrees not to hold Scuba Dogs and its employees, owners, officers, technicians or agents (hereinafter "**Released Parties**") liable or responsible in any way for any injury, death or other damages which may occur to the Customer or his/her family, heirs or assigns as a result of use of this equipment after serviced. In addition, the Customer agrees not to hold the Released Parties responsible for any loss or damage to the equipment as a result of fire, theft, accident or any other cause that may occur at its facilities. Furthermore, the Customer understands that the **equipment may have hidden damages** that may not be easily detectable such as a ripped hose, cracked regulator housing, or corroded internal parts that may be discovered during the service and require repair or replacement. If so and the cost exceeds twenty five dollars (\$25), Scuba Dogs will send video and/or picture evidence via text or email to the Customer, as well as an official recommendation and quote to obtain a written approve before attending to these hidden damages. Once the approved service is completed, the Customer understands that the equipment needs to be picked up and paid for within **fifteen (15) calendar days of notice of completion** and accepts to pay one dollar (\$1.00) per item per day fee for any equipment left after said time. If the equipment should exceed three (3) calendar months after notice without pickup, this equipment will automatically become property of Scuba Dogs. **By signing this agreement**, I confirm that I have carefully read and understand these terms. Furthermore, that I exempt and release the "Released Parties" from all liability or responsibility whatsoever for personal injury, property damage, or wrongful death as a result of using the equipment as already stated.
