(for diving related activities), government offices, industry partners as hotels and cruise lines, and sponsoring companies that help support our dive center (hereinafter referred to as the "Released Parties") may be held liable or responsible in any way for any personal injury, property damage, wrongful death, other damage or expenses to either me or any of my family members, heirs, or assignees that may occur during the aforementioned activities as a result of the negligence of any party; whether passive or active. Accordingly, I hereby waive any cause of action against the Released Parties, in their official and personal capacities, which could rise as a consequence of said negligence and/or activity.
